## <Important Notes about APOSTILLE Requirements>

Since July 14, 2007, the Republic of Korea has been a part of the 1961 Hague Convention abolishing the Requirement of Legalization for Foreign Public Documents. The Convention provides for the simplified certification of public(including notarized) documents to be used in countries that have joined the convention. The APOSTILLE ensures that public documents issued in one signatory country will be recognized as valid in another signatory country.

(This document is required to be submitted only by final candidates who have obtained a degree from a foreign(abroad) university.)

APOSTILLE certificates should be arrived at UNIST by 2026.01.16.(Fri.), (By Post or Visit) to UNIST Graduate Admissions Team.

A. Newly admitted students from countries which are signatories to the convention must submit as followed:

1. Official certificates(Transcripts and diploma) should be submitted with the APOSTILLE attached.
2. All documents should be in English. Documents in another language should be accompanied by a notarized English translation.

**\* Apostille or consular confirmed documents must be submitted in their original**

**form, and the submission of copies of the original is prohibited.**

- \* If the original certificate(Degree & Transcript) is issued only once, make a copy of the certificate and get the apostille(consular confirmation) on the copy.**
- \* Submitted documents can never be returned to students after enrolled at UNIST in any circumstances.**

### 3. The use of the model Apostille certificate

B. Students admitted from countries which are NOT signatories to the convention and do not recognize the APOSTILLE must submit as followed:

1. Official certificates(Transcripts and diploma) must be legalized by **the Korean embassy or consulate.**
2. All documents should be in English. Documents in another language

should be accompanied by a notarized English translation.




- ※ **Who has studied in China** should submit the document issued by the Ministry of Chinese Education with the Apostille (by the Ministry of Foreign Affairs of China).

- Previously, transcripts and degree certificates (graduation certificates) had to be confirmed by the Korean consulate in China before submission, but as China mainland has become a Country that signed the Apostille Convention, documents can now be submitted after getting an Apostille.
